INTRODUCTION

[BLENDED AQUATICS LLC] (“we” or “us” or “our”) respects the privacy of our clients (“client” or “you”). This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our website [<https://blendedaquatics.com>], including any other media form, media channel, mobile website, or mobile application related or connected thereto (collectively, the “Site”). COLLECTION OF YOUR INFORMATION

We may collect information about you in a variety of ways. The information we may collect on the Site includes:

Personal Data

Personally identifiable information, such as your name, address, email address, and telephone number, and demographic information, such as your age and/or gender, that you voluntarily give to us [when you register with the Site] or when you choose to participate in services related to the Site / Company. You are under no obligation to provide us with personal information of any kind, however your refusal to do so may prevent you from using certain features of the Site or accessing certain services.

Derivative Data

Information automatically collected when you access the Site, such as your IP address, your browser type, your operating system, your access times, and the pages you have viewed directly before and after accessing the Site.

DISCLOSURE OF YOUR INFORMATION

We may share information we have collected about you in certain situations. Your information may be disclosed as follows:

By Law or to Protect Rights

If we believe the release of information about you is necessary to respond to legal process, to investigate or remedy potential violations of our policies, or to protect the rights, property, and safety of others, we may share your information as permitted or required by any applicable law, rule, or regulation. This includes exchanging information with other entities for fraud protection and credit risk reduction.

Third-Party Service Providers

We may share your information with third parties that perform services for us or on our behalf, including payment processing, data analysis, email delivery, hosting services, customer service, and marketing assistance.

Online Postings

When you post comments, contributions or other content to the Site your posts may be viewed by all users and may be publicly distributed outside the Site in perpetuity.

Business Partners

We may share your information with our business partners to offer you certain products, services or promotions.

Social Media Contacts

Sale or Bankruptcy

If we sell all or a majority portion of our assets, undergo a merger, or are acquired by another entity, your data will be deleted from all electronic devices / databases containing your personal information. TRACKING TECHNOLOGIES

Cookies and Web Beacons
